- Reported on additional MS4 permit requirements regarding new rules on stormwater treatment and ponding

- Reported street sweeping will be second or third week in May

- Road restrictions go in effect this Friday (March 10)
- Damage to a mailbox
- Ash Tree with regards to EAB discussion
- Discussion on hiring a licensed forester to tag Ash Trees that are infected

#### Treasurer's Report – Gary Englert

- Receipts in reporting period: \$5,240
- Receipts year to date: \$12,916
- Disbursements in reporting period: \$43,321

- Disbursements year to date: \$91,269
- Capital Project Reserve Balance: \$798,236
- Debt Service Reserve Balance: \$10,614
- Reported on status update on CIP funding
- Reported on fundraising/donations reporting
- Donations for Jevne Park: Treasure will collect from and present to council
- Reported on status update on CIP funding,
  - This is now a 7.6 million dollar project (inflation and time)
  - Currently we have \$930,000 bond package for lift station (\$50,000 a year for 30 years)
  - Smaller communities in MN often use a metric of \$5,000 of dept per capita. 339 residents was our last census. Based on this our recommended maximum dept would be 1.7M (for 30 year term)
  - Looked at numbers on 4.5M bond at current interest rate of 4.5/5% about \$325,000 additional debt service on top of our current \$50,000 debt service. Every 1M bond is \$67,000 debt service. We are currently setting aside \$180,000.
  - Other reserves, lift station, road maintenance, etc...leaves us \$100,000 to put towards debt service without raising taxes
  - Guidance is city should not borrow more than an additional 1M.

Resolution 23-07 a resolution accepting a monetary gift of \$6,968.86 from various donors to benefit the city of medicine lake parks department for Jevne Park Project forwarded by Councilmember McNaughton and seconded by Councilmember Shaffer. Councilmembers, Tomczik, Heim, Shaffer, McNaughton in favor. Councilmember Hovey absent. Motion carried.
