 - Mayor Heim reported he is hopeful for a new committee for these important water/lake topics
 - Councilmembers discussed

Planning Commission Report – Jesse Swanson

- Reported on review of Ordinances with regards to the potable water JPA with City of Plymouth
 - Reported that our city Ordinances look fine with regards to JPA
 - City of Medicine Lake will adopt City of Plymouth potable water ordinances and there are no concerns from the Planning Commission
 - Suggest that city may develop proposals to encourage folks to connect into City water, such as:
 - if property is sold/purchased a house water hook up is required
 - if well goes bad city hook up is required
 - full remodel of house city hook up is required
 - increasing bathrooms
- Mayor Heim asked Jesse and the Planning Commission to develop a list of suggestions to encourage residents to hook up to city water and work City
- Initial hook-up fees/permits paid to City of Plymouth will be approximately \$4,000 plus the cost for personal connection to home and internal plumbing
 - This is the same fee that others pay to the City for hook-up (such as new developments etc...)

Treasurer's Report – Gary Englert

- Receipts in reporting period: \$119,807
- Receipts year to date: \$422,909
- Disbursements in reporting period: \$70,601
- Disbursements year to date: \$435,909

- Capital Project Reserve Balance: \$850,852
- Debt Service Reserve Balance: \$20,138
- Reported receipts included final settlement of 1st half 2023 taxes, SCORE grant, rental license fees, interest income, building permits
- Reported largest disbursements for 2022/2023 snow removal (largest yet), advisory services for Park project, and debt services
- Reported Jevne Park Project donations; total to date donations in year 2023 \$81,600; roughly \$16,000 donated in 2022; for an approximate total close to \$100,00 to date
